## SCHEDULE TOU-B COMMERCIAL TIME OF USE SERVICE

### AVAILABILITY

Available in all territory served by the Cooperative, subject to the Terms and Conditions of the Cooperative on file with the Virginia State Corporation Commission.

### APPLICABILITY

Applicable to commercial customers otherwise served under Schedule B. Net Metering customers are not eligible for this rate.

### TYPE OF SERVICE

Single phase, 60 cycle, at available secondary voltages; and multi-phase, where available, at secondary voltages. Motor installations shall meet the requirements of Section IV, Part H Electric Service Limitations of the Cooperative's Terms and Conditions for Providing Electric Service.

### MONTHLY RATE

#### I. Distribution Delivery Service:

##### Access Charges:

Single Phase Service	\$ 27.90	per month
Multi-Phase Service	\$ 55.70	per month

##### Energy Delivery Charges:

First 3,500 kWh delivered per month	@ \$ 0.03475	per kWh
Over 3,500 kWh delivered per month	@ \$ 0.02554	per kWh

#### II. Electricity Supply Service Charges:

All On-Peak kWh Sold – June – September	@ \$ 0.32951	per kWh
All On-Peak kWh Sold – October – May	@ \$ 0.15918	per kWh
All Off-Peak kWh Sold	@ \$ 0.04260	per kWh

Note: The above Distribution Delivery Service charges apply to those Customers who have an Electricity Supplier, other than the Cooperative, as their energy service provider. The above Distribution Delivery Service and Electricity Supply Service charges apply to those Customers who have the Cooperative as their energy service provider.

## **DETERMINATION OF ON-PEAK AND OFF-PEAK KWH**

1. For the months of October through May, On-peak kWh is defined as kWh used between the hours of 6:00 a.m. and 8:00 a.m. and between the hours of 3:00 p.m. and 8:00 p.m. on weekdays, excluding Thanksgiving Day, Christmas Day, New Year's Day, and Memorial Day. For the months of June through September, On-peak kWh is defined as kWh used between the hours of 3:00 p.m. and 8:00 p.m. on weekdays, excluding Independence Day and Labor Day.
2. Off-peak kWh is defined as all kWh not included in (1.) above.

## **MINIMUM MONTHLY DISTRIBUTION DELIVERY CHARGE**

The minimum monthly charge shall be the Access Charge as set forth above.

## **POWER COST ADJUSTMENT RIDER**

The amount of charges calculated under the above rates for Electricity Supply Service are subject to increase or decrease under provisions of the Cooperative's Power Cost Adjustment Rider, Schedule PCA-1.

## **TERMS OF CONTRACT**

The contract for service, except for Seasonal Service and Temporary Service, shall be for an initial term of not less than one (1) year, and shall continue in effect from year to year until terminated.
