**SCHEDULE I**  
**IRRIGATION SERVICE**

**AVAILABILITY**

Available in all territory served by the Cooperative, subject to the Terms and Conditions of the Cooperative on file with the Virginia State Corporation Commission.

**APPLICABILITY**

Applicable for electric service supplied to irrigation pumping loads not exceeding 50 kW demand.

**TYPE OF SERVICE**

Single-phase and multi-phase, 60 hertz at standard available voltages.

**MONTHLY RATE**

I. Distribution Delivery Service:

Access Charges:

Single Phase Service	\$ 20.00	per month
Multi-Phase Service	\$ 30.50	per month

Energy Delivery Charges:

All kWh Delivered	@ \$ 0.0041	per kWh

Horsepower Charge:

\$0.50 per horsepower per month; plus an additional \$3.00 per horsepower per month during the billing months of June through September, except that this additional charge shall not apply in any month in which 25 kWh or less is consumed.

II. Electricity Supply Service Charges:

Horsepower Charge:

\$3.80 per horsepower per month during the billing months of June through September, except that this charge shall not apply in any month in which 25 kWh or less is consumed. The horsepower charge shall be waived when the Customer agrees by contract to participate in the Cooperative's Load Management Program by allowing the Cooperative to prohibit on-peak usage with a load control switch installed on each pumping load.

Effective: On bills issued on and after October 1, 2018

## **MINIMUM MONTHLY DISTRIBUTION DELIVERY CHARGE**

The minimum monthly charge for distribution delivery service shall be the greater of the following:

1. Access Charge plus \$0.50 per horsepower.
2. Such other minimum charge specified in the contract for service as may be established by the special nature of the particular load as provided for in the Cooperative's Terms and Conditions.

Whenever a Customer applies for reconnection of service at the same location within an eighteen-month period of the time the service was disconnected, a charge equal to the sum of the minimum monthly bills determined for the months that the service was disconnected will be billed to the Customer and must be paid by the Customer before reconnection is made.

## **POWER COST ADJUSTMENT RIDER**

The amount of charges calculated under the above rates for Electricity Supply Service are subject to increase or decrease under provisions of the Cooperative's Power Cost Adjustment Rider, Schedule PCA-1.

## **DETERMINATION OF HORSEPOWER**

The horsepower for billing purposes shall be the motor manufacturer's nameplate rating of horsepower output, except that if the Cooperative so elects, the horsepower shall be determined by actual measurements of power input during a period of maximum normal use, less an allowance of ten percent of input for motor losses.

## **PERIODS OF LOAD MANAGEMENT**

Periods of load management when applicable shall begin when the Cooperative activates the load control switch installed on the Customer's pumping load and shall continue until the load control switch is deactivated by the Cooperative. Notice of the start and finish of Load Management Periods will be by signal provided by operation of the Cooperative's load management system.

## **CONTROL AND METERING EQUIPMENT**

When applicable, the Customer must agree to allow the Cooperative to install all necessary electrical and mechanical equipment used to prohibit or meter on-peak usage.

## **CONTRACT PERIOD**

The contract for service, except for Seasonal and Temporary Service, shall be for an initial term of not less than one (1) year, and shall continue in effect from year to year until terminated.
