OUTDOOR LIGHTING

AVAILABILITY

Available in all territory served by the Cooperative, subject to the Terms and Conditions of the Cooperative on file with the Virginia State Corporation Commission.

APPLICABILITY

Applicable upon request to Customers along the lines of the Cooperative for ground, highway or street lighting.

CHARACTER OF SERVICE

Service shall be rendered by use of a dark sky compliant LED outdoor light based on the manufacturer's nominal lamp rating.

CONTRACT TERM AND BILLING

Standard contracts shall be for a term of two (2) years and thereafter from year to year and terminated by notice of at least sixty (60) days from either party. Bills will be rendered monthly in accordance with the charges shown under monthly rate.

The Electric Supply Service Charge shall be applied to the listed "Monthly kWh" usage for the particular light type, as stated above, to determine the monthly rate.

DESCRIPTION OF EQUIPMENT TO BE SUPPLIED

Cooperative will install, own and maintain a standard LED type luminaire and bracket mounted on Cooperative owned poles.

TERMS AND CONDITIONS OF SERVICE

1. A standard installation is a standard fixture and standard arm installed on an existing Cooperative pole.
2. When additional poles and wiring, or non-standard fixtures, arms, poles, or associated equipment are provided by the Cooperative, monthly charges for Excess Facilities will be applied in accordance with Schedule EF. A five year contract will be required as per Schedule EF. Additional facilities on the Customer's premises will be owned and maintained by Cooperative.
3. When a lighting unit is attached to Cooperative facilities and is located along a public right of way, the lighting unit furnished under this Schedule must then extend over the Customer's private property and not over the public right-of-way. The decision as to the location of outdoor lighting fixtures on Cooperative facilities rests solely with the Cooperative and the installation of equipment must conform to the regulations of public authorities having jurisdiction in the area.
4. Lamps shall operate from dusk to dawn each night, approximately 4,100 hours per year.
5. The Cooperative will require payment for removals or relocations of new installations in service for less than two (2) years.
6. Installations and maintenance will be performed during normal working hours within a reasonable period following notification by the Customer to the Cooperative.
7. Cooperative reserves the right to discontinue service where cost of service is excessive because of vandalism or other reasons.
8. The Cooperative will only attach lighting fixtures to Cooperative owned facilities.
9. The Customer shall pay a one-time charge of \$75 if Customer requests another operational/working area light under Schedule PL to be replaced with an LED fixture.

POWER COST ADJUSTMENT RIDER

The amount of charges calculated under the above rates for Electricity Supply Service are subject to increase or decrease under provisions of the Cooperative's Power Cost Adjustment Rider, Schedule PCA-1.

TERMS AND CONDITIONS

The Cooperative's Terms and Conditions for Providing Electric Service, as filed with the Virginia State Corporation Commission, shall apply to service under this rate schedule.
